If I say, that every person in his daily routine, makes use of some or the other intellectual property. Do you know HOW?


Try to recollect all the activities you perform daily, since you get up in the morning till you go to bed at night.

### 3. Types of Intellectual Properties and the rights:


Mainly there are 5 types of Intellectual Properties.

Patent, Industrial Design, Trademark, Copyright and Geographical Indications

The Intellectual Property Rights (IPRs) are the exclusive rights or monopoly rights of ownership given to the creator of the respective Intellectual Property (IP).

Say for an example, if you want to protect / secure your tangible property like gold, jewellery, Money etc, you make use of lockers, banks to keep them safe. Also, you have life insurance for protecting your life. Then why not protect your IDEAs? Basically, most of us are not aware of the fact that something like protecting intellectual property exists.

Thus, these IPRs are the protective rights / protection to your IP. If any person / entity wants to use your creation, he cannot use it without your permission.



Patents –for protecting your inventions & ideas

Trademark – for protecting your business symbols, logos

Copyrights – for protecting your artwork, literature, music etc.

Industrial Design - for protecting shape, appearance, arrangement of design

Geographical Indications - for protecting identity of product having characteristics related to geographical origin.

4. Importance of IPRs – Brings a huge Monetary Value to the inventor

As mentioned above, the IPRs are the protection to your IP. If any person / entity wants to use

your creation, he cannot use it without your permission.

What does this mean?

This means, if any person interested in using your IP, has to pay royalty or fees to you as per

the valuation of your IP before he uses it. There are IP valuers who provide you this

information.

And the monetary value of your IP is much more than you could even think of. It could be

beyond your imagination. Only thing is we are not aware of the importance of such intellectual

property.

J.K Rowling – Novelist of Harry Potter - is one of the Live Examples where her literature - her

Intellectual Property has made her multi-millionaire.

Thus, the protection of IP brings in:

• HIGH Monetary gains / benefits

• Company valuation to CRORES

• Business sustainability in Competition
